



**TWO YEAR ORIGINAL EQUIPMENT PARTS AND LABOR/SERVICE WARRANTY
ALL NORLAKE COMMERCIAL REMOTE REFRIGERATED CABINET PRODUCTS
(REFRIGERATION SOLD SEPARATELY)**

WARRANTY COVERAGE: Norlake, Incorporated extends the following warranty to the original purchaser/user, which shall be deemed to mean the individual or company for whom the warranted product(s) was originally installed. It neither assumes, nor authorizes any person to assume, any obligation other than that covered by this warranty, and applies only within the continental boundaries of the United States of America, its territories and possessions, and Canada.

Norlake warrants this product to be free from defects in material or workmanship under normal use and service. In the event of failure, the obligation of Norlake under this warranty shall be limited to repairing or replacing with a like part, at Norlake's option, F.O.B. Hudson, WI, any original equipment part of the warranted original equipment product which proves defective, and which Norlake's examination shall disclose to its satisfaction to be thus defective, and which cannot be placed back into operation in the field with normal service efforts.

Norlake warrants this product to be free from defects in material or workmanship under normal use and service. In the event of failure, the obligation of Norlake under this warranty shall be limited to the reasonable labor cost, on a straight time basis, to repair the warranted product which proves defective. No overtime labor costs or travel time will be paid under this warranty. Unless preauthorized, a maximum of one hour travel is covered.

A replacement part installed as a result of this warranty is not subsequently covered by this warranty. Norlake reserves the right to require the return, collect freight, of any defective part. **A Norlake provided authorization number is required before the return of any parts or equipment.**

Should purchaser elect to obtain a replacement for the defective part locally in lieu of purchasing the part directly from Norlake, Norlake's financial obligation will be limited to reimbursement consistent with the purchaser's/user's then current purchase price for the defective part acquired from Norlake, Incorporated.

The warranty is in force for two (2) years from date of installation, but not longer than two (2) years, three (3) months from Norlake invoice date. Any claim for defects occurring between two (2) years and two (2) years, three (3) months from Norlake invoice date must furnish proof that installation did occur within three (3) months of Norlake invoice date.

WARRANTY EXCLUSIONS: This warranty does not apply to equipment which has been subject to removal from original installation site, dismantled and rebuilt, or subject to any accident, alterations by unauthorized service, negligence, abuse, misuse, or improper installation. This warranty does not include any labor or mileage charges for replacement or repair of defective parts. This warranty does not include replacement of any expendable items such as refrigerants, oils, filters or driers. This warranty does not apply to electrical inter-wiring, refrigerant piping, drain lines or field work provided by others. **NINETY DAY REPLACEMENT PARTS WARRANTY – ALL NORLAKE
COMMERCIAL REFRIGERATION PRODUCTS**

WARRANTY COVERAGE: Norlake, Incorporated extends the following warranty to the original purchaser/user, which shall be deemed to mean the individual or company for whom the warranted product(s) was originally installed. It neither assumes, nor authorizes any person to assume, any obligation other than that covered by this warranty and applies only within the continental boundaries of the United States of America, its territories and possessions, and Canada.

Norlake warrants this replacement part to be free from defects in material or workmanship under normal use and service. In the event of failure, the obligation of Norlake under this warranty shall be limited to repairing or replacing with a like part, at Norlake's option, F.O.B. Hudson, WI, the replacement part only of the warranted product which proves defective, and which Norlake's examination shall disclose to its satisfaction to be thus defective, and which cannot be placed back into operation in the field with normal service efforts.



A replacement part installed as a result of this warranty is not subsequently covered by this warranty. Norlake reserves the right to require the return, collect freight, of any defective part. **A Norlake provided authorization number is required before the return of any parts or equipment.**

Should purchaser elect to obtain a replacement for the defective part locally in lieu of purchasing the part directly from Norlake, Norlake's financial obligation will be limited to reimbursement consistent with the original purchaser's/user's then current purchase price for the defective part acquired from Norlake, Incorporated.

The warranty is in force for ninety (90) days from date of installation, but not longer than one hundred twenty (120) days from Norlake invoice date. Any claim for defects occurring between ninety (90) days and one hundred twenty days (120) from Norlake invoice date must furnish proof that installation date did occur within thirty (30) days of Norlake invoice date.

WARRANTY EXCLUSIONS: This warranty does not apply to equipment which has been subject to removal from original installation site, dismantled and rebuilt, or subject to any accident, alterations by unauthorized service, negligence, abuse, misuse, or improper installation. This warranty does not include any labor or mileage charges for replacement or repair of defective parts. This warranty does not include replacement of any expendable items such as refrigerants, oils, filters or driers. This warranty does not apply to electrical inter-wiring, refrigerant piping, drain lines or field work provided by others. This warranty does not apply to any failure as a result of use/abuse, site or environmental conditions.

It neither assumes, nor authorizes any person to assume, any obligation other than that covered by this warranty, and applies only within the continental boundaries of the United States of America, its territories and possessions, and Canada. This optional warranty is in lieu of any other applicable standard warranty.

Norlake warrants this product to be free from defects in material or workmanship under normal use and service. In the event of failure, the obligation of Norlake under this warranty shall be limited to repairing or replacing with a like compressor, at Norlake's option, F.O.B. Hudson, WI, the original equipment compressor only from the warranted original equipment product which proves defective, and which Norlake's examination shall disclose to its satisfaction to be thus defective, and which cannot be placed back into operation in the field with normal service efforts.

A replacement compressor installed as a result of this warranty is not subsequently covered by this warranty. Norlake reserves the right to require the return, collect freight, of any defective part. **A Norlake provided authorization number is required before the return of any parts or equipment.**

Should purchaser elect to obtain a replacement for the defective compressor locally in lieu of purchasing the part directly from Norlake, Norlake's financial obligation will be limited to a reimbursement consistent with the purchaser's/user's then current wholesale price for the defective compressor acquired from Norlake, Incorporated minus any applicable salvage value.

The warranty is in force for five (5) years from date of installation, but not longer than five (5) years three (3) months from Norlake invoice date. Any claim for defects occurring between five (5) years and five (5) years three (3) months from Norlake invoice date must furnish proof that installation date did occur within three (3) months of Norlake invoice date.

WARRANTY EXCLUSIONS: This warranty does not apply to equipment which has been subject to removal from original installation site, dismantled and rebuilt, or subject to any accident, alterations by unauthorized service, negligence, abuse, misuse, or improper installation. This warranty does not include any labor or mileage charges for replacement or repair of defective parts.
